The City Council is a legislative body responsible for making and passing laws at the local level, overseeing the city's budget, and representing the interests and concerns of the community.


City Council Members, elected to represent specific geographic areas known as wards, play a vital role in articulating and addressing the needs of their constituents. #### Council Rules of Procedure & Code of Conduct

- Ensures fair and transparent decision-making processes during council meetings.
- Promotes respectful and civil interactions among council members, staff, and the public.
- Upholds ethical standards, maintains public trust, and contributes to effective governance of the community.

#### Comprehensive Plan 2040

- Serves as a long-term vision document that guides growth and development through 2040.
- Outlines goals, policies, and strategies related to land use, transportation, housing, economic development, environmental protection, and community facilities.
- Ensures coordinated and sustainable development, facilitates informed decision-making by policymakers, and helps us achieve desired future outcomes while preserving quality of life and our community's unique character.

#### **City Charter/Ordinances**

- Functions as the City's constitutional document, defining its governance structure, electoral
  processes, and procedural rules for enacting laws and ordinances, and outlining legal parameters
  of authority for elected officials, departments, and administrative bodies.
- Promotes stability, accountability, and community empowerment in municipal decision-making.
- Rochester Code of Ordinances and City Home Rule Charter updates are distributed and retained in the office of the City Clerk and communicated quarterly to a select mailing list.

#### **Strategic Priorities**

- Strategic Priorities are key areas of focus identified by the City Council to guide decision-making and resource allocation. They provide a framework for addressing pressing issues and achieving long-term goals, ensuring alignment and coherence in city initiatives and projects.
- These priorities are typically reviewed during the 2-year budget cycle. The current Strategic Priorities are Affordable Living, Economic Vibrancy & Growth Management, and Quality Services.

#### **Budget**

- The City Council begins the 2-year budget cycle by adopting its priorities, goals, and strategies in the early part of the calendar year. The City Administrator guides the development of the operating budget and Capital Improvement Program (CIP) in accordance with the City Council priorities. City Council votes on budget adoption.
- The <u>Budget in Brief Document</u> offers an overview of the annual budget, where the money comes from, where the money goes, & notable Capital Improvement Projects.

#### **Action Plan**

- Developed and supported by City Teammates, the Action Plan outlines goals, objectives, and tactics aimed at advancing the Strategic Priorities selected by the City Council.
- City Teammates provide Action Plan updates to the City Council every six months at City Council Study Sessions.

# **City Organizational Structure**


Our City embraces a High Performance Organization (HPO) philosophy, prioritizing people, problem-solving, service optimization, and customer relationships to create an environment conducive to success. This philosophy takes a holistic approach, integrating culture, organizational structure, and team development.



Our operational framework is driven by three key components:

- The Forward Team responsible for crafting vision and strategy;
- 2) Impact Teams dedicated to executing initiatives aligned with shared goals; and
- 3) Leadership Forum focused on fostering communication, learning, and unity among departments and key leaders.

This structure ensures a cohesive goal-oriented approach to municipal governance. Additionally, alongside this goal-oriented approach, our operational model includes a traditional hierarchy as depicted in the <u>Organizational Charts document</u>.

## **Blueprint for re-envisioning Rochester Police Department**

The Blueprint for re-envisioning the Rochester Police Department (RPD) embraces the six critical pillars outlined in the 2015 Final Report of The President's Task Force on 21<sup>st</sup> Century Policing. Committed to fostering community partnerships and proactive problem-solving, RPD emphasizes the dynamic nature of community policing. To learn more, visit the <u>Blueprint Report</u>.

#### **Boards & Commissions**

Boards & Commissions serve as advisory boards for the City Council are comprised of community volunteers and are supported by City teammates. The Mayor interviews applicants and appoints members, subject to City Council confirmation. Selections are made as openings occur throughout the year. ## **Comprehensive Surface Water Management Plan (CSWMP)**

The CWSMP, set to replace the 1999 plan, is undergoing a three-phase process. Phase 1, completed in 2022, focused on scoping and information gathering. Phase 2, expected to conclude in 2024, entails plan development, while Phase 3, spanning from 2024 to 2026, involves drainage district modeling and ordinance updates. Key enhancements: expanding the scope to cover the entire drainage area, delineating 11 drainage districts, integrating social equity and climate resiliency, and emphasizing integrated stormwater management. ## **Council Meeting Agenda**

The City Clerk manages the creation and distribution of all Council agendas and the publishing of official minutes and all related official notices and documents. The City Administrator exercises final approval over the content of all City Council agendas. Meeting materials are published several days in advance of the meeting to ensure adequate time for Council review. Learn more on the City Meeting webpage.

#### **Elections**

The City Clerk's Office is responsible for hiring all election judges for all federal and state elections as well as securing polling places in the required precincts of the City. Administration and coordination of all special City elections are run through the City Clerk's Office. In the event of a Special Election, responsibilities include all publications, printings, judges, precincts, and supplies necessary for a successful election. #### Flood Control

The Flood Control System, constructed during the 1980s and 1990s, safeguards assets valued at over \$1.5 billion and is engineered to withstand a 200-year flood event. It utilizes seven reservoirs, six of which are city-owned, to retain 16% of floodwater for controlled release over 10 days. Consisting of levees, floodwalls, channels, and strategically located city lands, it effectively manages floodwaters. Developed with the Army Corps of Engineers and NRCS, it includes recreational and aesthetic enhancements. No property taxes funded its construction or maintenance; instead, funding came from Local Option Sales in 1983, 1989, and 2023. #### **Legislative Policies**

## **Library Master Plan**

The Library is beginning a Study in 2024 to develop current and long-range plans for library services delivery. This will be a first-of-its-kind plan for Rochester Library Services.



### **Library Strategic Plan**

The Library Board sets strategic directions for the Library through the Library Strategic Plan. Focus areas include Equity, Connections, and Infrastructure. Learn more on the Library's <u>Vision, Mission & Planning webpage</u>.

#### Licenses

All annual regulatory licensing (such as gambling, contractors, transportation, massage, liquor, special events, etc.) are obtained and renewed through the Office of the City Clerk. Two major licensing periods throughout the year occur in the first and fourth quarters. Learn more by visiting the <u>Licenses webpage</u>.

## Organizational Legal Advice

The Office of the City Attorney is responsible for all of the City's legal business. As such, the City Attorney serves as the legal advisor and representative for the City of Rochester. The City Attorney is the attorney for City officials and employees (for actions taken in the course of their public duties), City departments, boards, and commissions. The City Attorney cannot represent private citizens in their legal matters. Learn more on the City Attorney webpage.



#### **Parking Rate Study**

The Parking Rate Study, last conducted in 2020, is set for a comprehensive update in 2024. This study entails a thorough analysis of parking rates and associated factors, culminating in strategic recommendations to optimize parking management. Notably, Public Parking operates as an enterprise fund, where program revenue offsets operational costs, ensuring financial sustainability and effective service delivery to the community.



#### Park Master Plan

The Citywide Parks and Recreation System Plan was adopted in 2016. Park-specific Master plans are currently in development for the following parks: <u>Soldiers Field Park</u>, <u>Silver Lake Park</u>, and MLK Park. #### Public Inquiries on Public Works Services

Many highly visible services generate public interactions and feedback to Councilmembers. Teammates assist Councilmembers in responding to these inquiries. Frequent topics include Traffic Concerns, Feedback about Snow Removal, Inquiries about Street Maintenance Activities, Stormwater Concerns, etc. View the Service Request Portal at <a href="https://www.rochestermn.gov/servicerequest">www.rochestermn.gov/servicerequest</a>.



#### **Public Works Request for Council Action (RCA)**

Public Works generates a relatively high volume of RCAs for council consideration. Frequent requests include:

- Contracts for Capital Improvement Program (CIP) and maintenance projects
- Development agreements
- Easements, revocable permits, right-of-way changes, etc.
- Policy and ordinances updates

#### **Public Music**

Public Music provides the community with fun and memorable music events, including <u>Riverside Concert Series</u>, <u>FORWARD</u>, <u>Sound School</u>, and <u>Passport Sessions</u>.

The FORWARD series, established in 2019, features local music and local parks on Wednesday evenings in June and August. There's one concert per ward, co-hosted by Councilmembers in neighborhood parks. These free events highlight local bands and regional headliners and feature local food vendors, Rochester Public Library's Bookmobile, and Parks & Recreation's Mobile Recreation Trailer.



#### Sanitary Sewer Wastewater Master Plan

The Sanitary Sewer Wastewater Master Plan, adopted in 2020 from the Planning 2 Succeed Comprehensive Plan 2040, is a thorough strategy for our infrastructure needs. It assesses current sewer system capacity, infrastructure condition, and future growth projections. Split into 7 Sewer Districts, it plans for growth efficiently. The estimated cost for expansion and improvement projects is \$362 million. It's in line with the Growth Management Map and follows a Capital Improvement Plan guided by Council priorities. ## **Transit Development Plan**

The 2022 Transit Development Plan outlines a comprehensive 5-year strategy to shape transit services. With a focus on improving fixed route and paratransit services, managing capital assets, integrating advanced technology solutions, and ensuring sustainable fare structures and funding mechanisms, the plan aims to enhance accessibility and reliability for commuters. Additionally, it explores opportunities to introduce new services, aligning with evolving community needs and enhancing public transportation effectiveness.
